- Maintain strict confidentiality (no less than reasonable care).
- No disclosure to third parties without prior written consent.
- Restrict internal access on a need-to-know basis only.

Exclusions

Confidentiality does not apply to information that is:

- Already public without fault of Receiving Party.
- Lawfully obtained from third parties.
- Independently developed without use of Confidential Information.
- Disclosed by legal requirement (with prompt notice to Bioxel SA).

Duration

Binding for 5 years from last disclosure.

Return / Destruction

Upon request, all confidential material must be returned or destroyed, with certification of destruction.

Remedies

Unauthorized disclosure may cause irreparable harm. Bioxel SA may seek injunctive relief in addition to damages.

Governing Law & Forum

This NDA is governed by Swiss law.

Disputes are settled by arbitration in Geneva (in French) under ICC or Swiss Chambers rules.
